- 7.2 Planning application BA/2020/0055/FUL to relocate southern boundary, replacement building, relocate access, replace timber quay heading with galvanized steel and new mooring cut at land at Broad View, Fleet Lane, South Walsham Clerk to report that Council feel the plans show a modern property out of keeping with the existing ones within that area. It was suggested that a thatch roof would be preferred.

8. CHURCHYARD

Council AGREED that Mr and Mrs Arrowsmith-Brown may, at their own cost, and subject to the necessary permissions from Broadland District Council and the Church being in place, arrange to have the branches overhanging their garden lopped from the sycamore tree in the churchyard – resolution to be signed by Clerk

9. CORONAVIRUS

- 9.1 Council NOTED that the Clerk applied for a grant to help the parish community efforts during this pandemic and AGREED Council will make all decisions regarding spending such funds by email. Applications for funds to be made direct to the Clerk who has been given delegated powers by Council to spend up to half the grant without recourse to Council.
- 9.2 Council NOTED that the playground is locked, as per government advice, and that the usual equipment checks will not be taking place until further notice. Kingfisher Lane car park also closed to discourage people from travelling to visit our village during the lockdown as very busy over the weekend.
