# 3. MINUTES OF PREVIOUS MEETING

The minutes of the Parish Council Meeting held on 6<sup>th</sup> January 2020 signed by the Chair as a true and correct record.

#### 4. PUBLIC FORUM

- 4.1 District Councillor Justine Thomas reported that she has member led funding of £500 available for projects for local groups in the community applications direct to her Report from County Councillor Fran Whymark: ongoing Boundary Commission consultation; The plans for Housing with Care at Herondale in Acle have been approved; Rough Sleeper work to continue with an additional member of staff.
  - Report from the Police: 1 recorded crime at the Village Hall
- 4.2 Public Forum: acknowledgement of thanks to Cllr Jones and P Randell for improving the entrance of the cemetery at such short notice ready for the funeral the following day; Mud on Wymers Lane partially cleared today, although brought to farmer's attention at beginning of previous week; suggestion to place a sign at the cemetery entrance to prevent HGV's using it as a layby; Smell from the flooding at The Street very bad last week Cllr Russell asked that pictures be taken by residents to build up evidence; concerns that tankers at the pumping station have no signs to warn oncoming traffic Clerk to report to Anglian Water.

- 8.5 It was AGREED that Council minutes 2000 to 2017 are to be bound for £90 before depositing at Norfolk Record Office

# 9. CEMETERY & CHURCHYARD

- 9.1 The notes of the JCBF meeting held 13<sup>th</sup> January 2020 were received
- 9.2 Council AGREED these JCBF recommendations:
  - 9.2.1 to accept Abbey Memorial quote to stabilise the Jermy headstone in cemetery
  - 9.2.2 to ratify the emergency tree work carried out at the churchyard 05/2020

- 9.2.3 to note Norwich Electrical to investigate switch fault at churchyard gate
- 9.3 Council AGREED the expenditure to improve the entrance to the cemetery and that 1 tonne of pea shingle should be added on top of the 2 tonnes of type 1 already laid. Cllr Jones to organise.
  Removal of the conifers at the cemetery to be postponed until autumn due to difficulties obtaining quotes and the supply of the temporary net. Council also addressed issues raised by a reader of The Mardler with concerns about danger to wildlife.

## 10. VILLAGE HALL AND RECREATION GROUND

- 10.1 Council considered the request for a removable post to be installed at entrance to cemetery and it was AGREED to consider limiting access between the recreation ground and the cemetery as a temporary measure until such time as a more permanent solution could be approved
- 10.2 It was AGREED that an advertising board for the Village Hall could be erected using posts at the parish staithe
- 10.3 It was noted that the Memorandum of Agreement between the Council and the Village Hall is now signed and dated.

# 11. GROUNDS MAINTENANCE CONTRACTS

Clerk has spoken to Robert Rice of The Garden Guardian and he is agreeable to meeting with Council in April for a walk around the village. Clerk to advise that Village Hall are now maintaining their grounds so contract specification needs revision.
