12. KINGFISHER LANE CARPARK

Car park has been re-opened due to problems caused by large number of vehicles parking on the verges and obstructing deliveries to houses in Broad Lane. Car park full as soon as reopen and still unable to cope with demand, albeit with fewer cars parked on verges. Cllr Russell monitoring situation.
